## An Eye for An Eye

<sup>23</sup> If any harm follows, then you shall give life for life, <sup>24</sup> eye for eye, tooth for tooth, hand for hand, foot for foot, <sup>25</sup> burn for burn, wound for wound, stripe for stripe. Exodus 21:23-25 NRSV

<sup>38</sup> "You have heard that it was said, 'An eye for an eye and a tooth for a tooth.' <sup>39</sup> But I say to you, Do not resist an evildoer. But if anyone strikes you on the right cheek, turn the other also; <sup>40</sup> and if anyone wants to sue you and take your coat, give your cloak as well; <sup>41</sup> and if anyone forces you to go one mile, go also the second mile. <sup>42</sup> Give to everyone who begs from you, and do not refuse anyone who wants to borrow from you.

Matthew 5:38-42 NRSV

A death row inmate in Mississippi barely avoid execution this week when the Mississippi Supreme Court ruled that DNA testing should go forward. This was a reversal of a prior ruling denying DNA testing even though no physical evidence connected the black defendant to the crime of killing two white college students. It was only after the FBI acknowledged that its expert offered invalid scientific opinions concerning some hair found at the scene that the Mississippi Supreme Court relented and stayed the execution. In another story, the State of Maryland just this month ended the practice of Capital Punishment. That leaves 32 States, including Tennessee, and the Federal Government that allows the Death Penalty. According to the Death Penalty Information Center, Tennessee has executed 6 persons since 1974 when the Death Penalty was reenacted. There are currently 87 condemned prisoners. The State has also released 2 prisoners since 1974 who were proven to have been wrongly convicted.

The bible, as happens from time to time, can be used to support or oppose Capital Punishment. There are texts in addition to those included above, including this one from Genesis. God, speaking to Noah after the flood says:

<sup>5</sup> For your own lifeblood I will surely require a reckoning: from every animal I will require it and from human beings, each one for the blood of another, I will require a reckoning for human life.

Whoever sheds the blood of a human, by a human shall that person's blood be shed; for in his own image God made humankind. Genesis 9:5-6

That seems to be an unambiguous statement. It could be read to mean that we should allow God to take the life, but I don't think such a reading is fair to the text. There is no doubt that the People of Israel, and many other people in different times and places, believed that the taking of a life called for the forfeit of a life.

Based upon the text from the Sermon on the Mount quoted from Matthew it would seem that Jesus opposed the Death Penalty. Indeed, even from the cross Jesus offered a prayer for those who took his life:

<sup>34</sup> Then Jesus said, "Father, forgive them; for they do not know what they are doing." Luke 23:34 NRSV

The "eye for an eye" law was originally imposed upon the people during their nomadic trek. It was meant to supplant the law of vendetta, blood feuds where whole families might be wiped out in retaliation for the crime of one of its members. Jesus told the people that the time for such a law had passed.

So, what is the response of a Christian to the death penalty? I can only answer for myself that I am opposed to it as both a lawyer and a Christian. You see, in order to have the ability to impose the death penalty we have to accept that some number of innocent lives will be taken. For me that is too high a cost.

My law license is on inactive status but I remain an attorney and an officer of the Courts of Tennessee and the Courts of the United States. Although I never practiced criminal law, I have a great deal of experience with our civil justice system which, in the final analysis, is essentially the system used to determine guilt in criminal cases. The system does not determine innocence, since all are presumed innocent. When someone is tried for a crime the system determines if, beyond a reasonable doubt, they are guilty "as a matter of law." As we have seen many times around the nation, the system is far from infallible. Sometimes people are wrongfully convicted and it is no easy matter to get the earlier conviction set aside. That determination that you are guilty "as a matter of law" carries great weight.

When I was practicing law I would explain to clients that the civil justice system, if pressed to try a case before a Judge or Jury, would provide a result 100% of the time. Hopefully that result would comport with law and the facts, but there were no guarantees. Sometimes the result is influenced by simple error, sometimes by malice or malfeasance and sometimes by outright stupidity. This is true for both Civil and Criminal Courts. All an accused criminal is promised is a result reached, hopefully, with great care and in accordance with law and fact. That result may be wrong. This is why so many civil and criminal cases are settled short of trial.

I believe that our criminal justice system is one of the best and fairest in the world. Nevertheless, we know that it will sometimes make mistakes. People have spent decades in prison for crimes they did not commit. We are equally certain that some number of people executed in this nation have been wrongfully murdered by the State for crimes they did not commit because we have discovered people sentenced to life in prison for murder but later exonerated. It stands to reason that some unknown number of those executed over the years have not been guilty. If someone is wrongfully given life imprisonment, there is the possibility of correcting the mistake despite the huge injustice involved with locking someone away for a crime he did not commit. Once we have taken a life, the mistake can never be rectified.

I would be less than honest if I did not admit that there are people that I thought should be executed. The Boston Bombers come to mind. And, if one of my family members was the victim of murder or some other heinous crime, I think I would probably want those responsible killed even though I also believe that is wrong. But I can state that if, in order to have my revenge, it is necessary to kill some number of innocent people then the matter takes on a different light. And I am certain that is the price of having the death penalty. The Justice system is a human creation and it is far from perfect. It will make mistakes. It is not reliable enough to determine questions of life and death.

A fundamental underpinning of Christianity is belief in Justice and Righteousness. There are over 600 verses in scripture that use one or the other of those terms, often both. Time and again in scripture God is

depicted proclaiming that the people are to live just and righteous lives. It matters how we deal with one another. That concept is at the core of all that Jesus taught. No matter how much due process is attached to the act, there is nothing of justice and righteousness associated with executing someone for a crime they did not commit. Consider that, by the standards of the day, Jesus was given as much, or more, "due process" as most whom experienced the Roman Judicial System.

In closing, consider one more scripture, one of my personal favorites:

He has told you, O mortal, what is good; and what does the LORD require of you but to do justice, and to love kindness, and to walk humbly with your God. Micah 6:8

The potential misuse of online information is something that we all need to be careful about.
